It is the duty of all concerned with the San Jose Japanese Community Youth Service (JCYS) to emphasize the proper ideals of sportsmanship, ethical conduct and fair play. Participants, coaches, managers, and parents are expected to respect the integrity and judgment of officials to show courtesy to visiting teams, and to recognize that the purpose of the game is to promote the physical, mental, moral, social, and emotional well-being of the participants.

JCYS members (including participants, their parents, coaches, managers and fans) represent JCYS and are JCYS' ambassadors at each event. As such they are to adhere to the following:

1. Members are to conduct themselves in a sportsman-like manner, emphasizing the proper ideals of sportsmanship, ethical conduct, and fair play, both on and off the field of the event, while they are representing JCYS. Members represent JCYS throughout their attendance (until departure) of each event. Members are to refrain from the use of profanity or "trash" talking while at a JCYS event.
2. Members will show courtesy to all of the officials, coaches, participants, fans, and managers. Members will not direct abusive or profane language to them or undermine their authority. Furthermore, no physical confrontations of any kind between members and officials, coaches, managers, and participants will be tolerated. Members are expected to respect and listen to their coaches, managers, and parents supporting JCYS at all times.
3. As a team, members are to monitor each other and are expected to keep in line fellow team members who are not representing JCYS in the proper manner. Members should initially discuss any problems with the team manager and/or coach. If there is no resolution, then the appropriate commissioner should be notified.

Participation in JCYS is a privilege. Any violation of any part of the Code of Ethics or Rules of Conduct may jeopardize the member's participation in the JCYS program.
